- a) To qualify for CAHOOTS payments, a hospital must meet the following criteria:
 - 1) Hospital located in Illinois; and
 - 2) A Critical Access Hospital as defined in Section 148.25(g).

- b) Each hospital qualifying under subsection 148.200(a), that are owned or operated by an Illinois government body or municipality, shall be paid a quarterly CAHOOTS payment equal to the product of:
 - 1) \$875,000.00.
 - 2) The lower of:
 - A) A quotient of:
 - i) the numerator of which is the hospital's adjusted outpatient claims in the data quarter; and
 - ii) the denominator of which is the total of all qualifying hospitals' adjusted outpatient claims in the data quarter; or
 - B) 10%.

- c) Each hospital qualifying under subsection 148.200(a), that are not owned or operated by an Illinois government body or municipality, shall be paid a quarterly CAHOOTS payment equal to the product of:
 - 1) \$2,500,000.00.
 - 2) The lower of:
 - A) A quotient of:
 - i) the numerator of which is the hospital's adjusted outpatient claims in the data quarter; and

419 2) "Data Quarter" means the quarter of the calendar year that begins six
