HOUSE BILL 4079. Introduced by Representative Evans, AN ACT concerning public aid.

HOUSE BILL 4080. Introduced by Representative Niemerg, AN ACT concerning State government.

HOUSE BILL 4081. Introduced by Representatives Chesney, Sosnowski, Wilhour, Niemerg, Halbrook and Miller, AN ACT concerning vaccines.

HOUSE BILL 4082. Introduced by Representative Friess, AN ACT concerning education.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 293

Offered by Representative Gonzalez:

WHEREAS, To protect the millions of Americans who live near roadways or live with a lung disease like asthma and to curb carbon pollution from the transportation sector, the U.S. Environmental Protection Agency must set a stronger clean truck standard; and

WHEREAS, Heavy-duty vehicles on the road release 45 percent of the U.S. transportation sector's nitrogen oxide (NOx) pollution, which creates ozone, the main ingredient in smog, and 57 percent of the transportation sector's fine particulate matter pollution; and

WHEREAS, Two-thirds of all Illinois residents live in areas that are designated by the U.S. Environmental Protection Agency as areas that fail to meet minimal air quality health standards for ozone under the provisions of the Clean Air Act; and

WHEREAS, Fine particulate matter is associated with an increased risk of premature death, hospitalization, and emergency room visits, and numerous respiratory and cardiovascular diseases are linked to ozone and fine particulate matter, such as asthma, decreased lung function, heart attacks, and lung cancer; and

WHEREAS, A 2020 study estimated that more than 20,000 people die prematurely every year in the United States as a result of the health burden from motor vehicle pollution on roads and highways; and

WHEREAS, Residents living near ports, railyards, warehouses, and busy roads are exposed to such high rates of heavy-duty vehicle pollution that experts have labeled these areas "diesel death zones" because asthma rates and cancer risks are so drastically elevated; and

WHEREAS, Living within just one third of a mile of a highway or close to ports, warehouse distribution centers, or other freight corridors is devastating for lung health and can lead to early death; and

WHEREAS, Low-income and communities of color comprise many of the residents in these regions, causing significant aggravated health problems and risks for these Americans; and

WHEREAS, In Illinois, transportation has recently overtaken fossil fueled power plants as the largest emitter of carbon dioxide, the largest contributing factor to global warming and climate damage; and

WHEREAS, Poor and minority communities bear much of the brunt of climate change in Illinois, including damage from flooding and excessive heat, in addition to already being burdened by air pollution; and

WHEREAS, Trucks and buses only account for 4 percent of vehicles on the road, and yet, they are responsible for nearly 25 percent of total transportation sector greenhouse gas emissions; emissions from

trucks are the fastest growing source of greenhouse gases, and the number of truck miles traveled on the nation's roads is forecast to continue to grow significantly in the coming decades; and

WHEREAS, A strong clean truck standard will expand the market for new, advanced technologies and create jobs; and

WHEREAS, Over a quarter-million people were employed in the clean vehicle industry in 2019; and

WHEREAS, Electric trucks and buses, regardless of who owns them, can reduce electric bills for all customers by using the electric grid to charge when electricity demand is low; and

WHEREAS, Today, at least 70 electric truck and bus models are on the market, and manufacturers are expected to make many more new models commercially available over the next decade; and

WHEREAS, Electric vehicles are being produced in Illinois, and Rivian has a contract to produce 100,000 electric delivery vans within this decade at a factory in Normal; and

WHEREAS, Navistar International, headquartered in Lisle, is already manufacturing and selling electric school buses and has begun building a facility to manufacture and sell electric trucks as soon as 2022; and

WHEREAS, The Multi-State Medium and Heavy Duty Zero Emission Vehicle Memorandum of Understanding (MOU), organized by the Northeast States for Coordinated Air Use Management (NESCAUM), calls for 30 percent of new truck and bus sales to be zero-emission by 2030 and 100 percent zero-emission by 2050; and

WHEREAS, California, Connecticut, Colorado, Hawaii, Maine, Maryland, Massachusetts, New Jersey, New York, North Carolina, Oregon, Pennsylvania, Rhode Island, Vermont, and Washington, as well as the District of Columbia, have issued an MOU outlining a coordinated effort to expedite the deployment of zero emission medium and heavy-duty vehicles; and

WHEREAS, This multi-state initiative is vital for enabling the policies with regulations, and it fosters cost-effective vehicle electrification needed to achieve state climate commitments and air quality improvement goals; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor to sign the Multi-State Memorandum of Understanding calling for 30 percent of new truck and bus sales to be zero-emission by 2030 and 100 percent zero-emission by 2050.

HOUSE RESOLUTION 294

Offered by Representative Durkin:

WHEREAS, The members of the Illinois General Assembly are deeply concerned about the rise of anti-Semitism throughout the United States and in the State of Illinois; and

WHEREAS, Anti-Semitism is the centuries-old bigotry faced by Jewish people simply because they are Jews; and

WHEREAS, The members of the Illinois General Assembly are deeply concerned by the growing number of incidents of anti-Semitism at the University of Illinois that led to a federal complaint with the Office of Civil Rights at the U.S. Department of Education; and

WHEREAS, The members of the Illinois House of Representatives stand in solidarity with Jewish students at the University of Illinois at Urbana-Champaign and all Jewish students who encounter incidents of anti-Semitism; and

WHEREAS, The University of Illinois at Urbana-Champaign needs to take immediate action to protect Jewish students at the university and stop the scourge of anti-Semitism at our state's flagship public university; and

WHEREAS, The U.S. Department of State, states, and local governments across the United States have adopted the International Holocaust Remembrance Alliance working definition of anti-Semitism to use as a resource in combatting the scourge of anti-Semitism at home and abroad; and

WHEREAS, The Governor of Illinois, as an ex-officio member of the Board of Trustees of the University of Illinois, needs to take immediate action to press the university to protect students from anti-Semitism; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage the University of Illinois

Board of Trustees to utilize the International Holocaust Remembrance Alliance working definition of anti-Semitism as a basis for recommending policies and actions to stop anti-Semitism at the University of Illinois; and be it further

RESOLVED, That the Board of Trustees of the University of Illinois is encouraged to report to the Board of Higher Education and the Illinois General Assembly by August 1, 2021 and every 180 days thereafter on steps being taken by the university to implement such policies, including mandating training to counter anti-Semitism among administrators and faculty, mandating anti-Semitism awareness for new students, and enforcing a student code of conduct that prohibits intimidation and disruption of Jewish students and organizations on campus; and be it further

RESOLVED, That suitable copies of this resolution be delivered to each member of the University of Illinois Board of Trustees.

HOUSE JOINT RESOLUTION 46

Offered by Representative Welter:

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to individuals who have given their lives in the line of duty; and

WHEREAS, Morris Police Department Patrolman Clarence Roseland's honorable service was tragically cut short when he was killed in the line of duty on February 3, 1935; and

WHEREAS, Patrolman Roseland left behind his wife, Bertha, and his children, Marge, Lois, Wayne, and Chuck; and

WHEREAS, On the night Patrolman Roseland was killed, both he and his partner, Ed Garrity, were making their regular rounds patrolling the stores and businesses in the downtown area; and

WHEREAS, While on the 800 block of Liberty Street, Officer Garrity had gone into a nearby building to attend to some personal matters; Patrolman Roseland began to walk the streets, checking local business; and

WHEREAS, When Patrolman Roseland reached Gable's Grocery Store on the east side of the street, he discovered the door was open; he entered the store and was confronted by a man with a gun; he had interrupted a robbery in progress by three armed men; and

WHEREAS, Patrolman Roseland was forced at gunpoint to return to his vehicle; when Officer Garrity returned to the squad car, he found that Patrolman Roseland had been shot from behind in cold blood and had died almost instantly; and

WHEREAS, The robbers fled the scene with a female hostage, who they released later near Joliet; the criminals robbery yielded a total of less than \$60; and

WHEREAS, After several months, the robbers were apprehended, and Louis Lutz was charged with the murder of Patrolman Roseland; and

WHEREAS, The murder of Patrolman Roseland was a tragedy that greatly affected the residents of Grundy County for many years to come; he was a great and noble man who was a respected citizen of his community; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate the portion of Illinois Route 47 over the Illinois River bridge from Pine Bluff Road to Washington Street as the "Patrolman Clarence Roseland Memorial Road"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name of the "Patrolman Clarence Roseland Memorial Road"; and be it further

WHEREAS, Marshal Hopkins' honorable service was tragically cut short when he was killed in the line of duty on September 14, 1878; and

WHEREAS, On the night of September 14, notorious roughs Frank Foster and Charles Miller came to town; the pair shortly became intoxicated; and

WHEREAS, Marshal Hopkins advised the men several times over the course of the evening to go home as they became disorderly; Foster and Miller ignored the multitude of warnings they received and persisted with their drinking until late into the evening; and

WHEREAS, Around midnight, Marshal Hopkins found it necessary to arrest the two drunk men and caught them in a downtown alleyway; as Marshal Hopkins was leading them out of the alley, the men fled on foot; and

WHEREAS, Marshal Hopkins pursued the men when Charles Miller suddenly drew his revolver and fired twice at the officer; Marshal Hopkins was hit by one of the shots and died almost instantly; and

WHEREAS, The funeral for Marshal Hopkins was the largest seen in Morris at the time; he was an honored member of the Masonic Order, a great, noble man, and a respected citizen of the community; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate the portion of Illinois Route 47 over Interstate 80 from Romines Drive to Illinois Route 6 East as the "Marshal Enoch T.
