I am surprised by the creation of the Safety and Violence Prevention Task Force in light of the passage of House Bill 3653 - Speaker Madigan's last "gift" to Illinois and its signing into law by Governor Pritzker. At the bill signing ceremony, Governor Pritzker and other Democratic leaders claimed, amongst many other things, that the legislation brings start closer to "true safety" and "the legislation ensures safe communities."

Those statements are the furthest thing from the truth. In light of the violence that is crippling the state of Illinois and the city of Chicago, I am not surprised by the quick formation of this task force. That attitude towards law enforcement is being heard loud and clear on the streets of Chicago.

I notice that eight of your thirteen Democratic appointees to the committee voted for HB 3653. I find those appointments odd based on the Governor's and Democratic legislator's statements that police reform will make our state safer. Don't thing for a moment that this task force will repair the harm done to law enforcement to last January - the damage is done.
