HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 610

Offered by Representative Flowers:

WHEREAS, This year will mark the 34th anniversary of the establishment and recognition of National Black Nurses Day by the 101st United States Congress; and

WHEREAS, Blacks have long been active in the nursing field; currently, they comprise five percent of the total nursing population and practice in a variety of areas, including clinical, education, administrative, research, government, and private enterprise; and

WHEREAS, Black nurses have made significant contributions to the nursing profession; as attention to the health care problems of minorities and the poor increases, Black nurses can be credited for establishing an environment of quality, service, and skill that patients have come to expect from health care practitioners; and

WHEREAS, Since February honors the contributions made to this country by Black Americans, it is fitting that Black nurses be recognized and honored for their outstanding contributions to our communities and our country; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare February 2022 as Black Nurses Month in Illinois; and be it further

RESOLVED, That we urge all citizens of Illinois to acknowledge the tireless efforts and selfless service contributed by African American nurses every day.

HOUSE RESOLUTION 611

Offered by Representative Ammons:

WHEREAS, Reverend Dr. Martin Luther King Jr. walked into the heart of Jim Crow demanding change from those intransigents in their hatred; his courage was unquestioned, his method of nonviolence was risky, and his style was unapologetic; and

WHEREAS, At 34 years of age, Dr. King received international recognition with the awarding of the Nobel Peace Prize; and

WHEREAS, The U.S. Federal Bureau of Investigation (FBI) immorally recorded the life and conversations of Dr. King; and

WHEREAS, The FBI began monitoring Dr. King in December 1955 during his involvement with the Montgomery Bus Boycott and engaged in covert operations against him throughout the 1960s; and

WHEREAS, For the last four and one-half years of his life, from November 1963 until his death in April 1968, Dr. King lived without any semblance of privacy; his hotel rooms were bugged, his phones tapped, and his office and inner circle infiltrated by informants; and

WHEREAS, On November 21, 1964, the FBI anonymously sent Dr. King a letter encouraging him to commit suicide to avoid public embarrassment; and

WHEREAS, According to a U.S. Senate Committee convened in the 1970s to investigate the FBI's domestic intelligence operations, when Dr. King condemned the Vietnam War in a speech at Riverside Church on April 4, 1967, the FBI interpreted this position as proof he "has been influenced by Communist advisors" and increased their covert operations against him; and

WHEREAS, In August 1967, the FBI created a counterintelligence program, COINTELPRO, which targeted Dr. King, the Black Panther Party, and other civil rights leaders; and

WHEREAS, The FBI's surveillance tapes and the transcripts of them remain under seal until 2027; and

WHEREAS, Dr. King is critical to memorializing the Black experience in America; his mission and the challenges he unfortunately confronted remain timeless, and no one has the right to feed on his legacy; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Governor Pritzker to express written support for the destruction of the National Archives and Record Administration's immorally obtained surveillance tapes on Dr. Martin Luther King; and be it further

RESOLVED, That we urge Governor Pritzker to work with the Illinois General Assembly to pass legislation that will prevent similar abuses of power from being perpetrated for immoral and defamatory reasons; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor Pritzker, Lt. Governor Stratton, Governor Pritzker's Office of Equity, and the Illinois Attorney General.

HOUSE RESOLUTION 614

Offered by Representative Conroy:

WHEREAS, Kawasaki Disease (KD) is a serious illness characterized by inflammation of blood vessels throughout the body, which primarily affects young children and can lead to permanent heart disease; and

WHEREAS, Kawasaki Disease can cause devastating consequences, including life-long aneurysms, stent placement, heart transplants, skin disorders, and childhood anxiety; and

WHEREAS, Kawasaki Disease is the number one cause of permanent heart disease in children; it is diagnosed in approximately 4000 to 5000 U.S. children annually, primarily under the age of eight and across racial, ethnic, and socioeconomic lines; and

WHEREAS, Scientific studies indicate that genetic inheritance is an important risk factor of Kawasaki Disease; and

WHEREAS, Despite the serious consequences that can manifest in children with Kawasaki Disease, there have been recent instances of young adults suffering heart attacks in their 20s and 30s, which then reveal old aneurysms and a missed diagnosis of KD as a child; and

WHEREAS, Underprivileged and minority communities are particularly devastated by the high cost of known treatment for Kawasaki Disease; and

WHEREAS, The American Heart Association, the World Heart Federation, and the National Institute of Health recognize the need for proper and timely diagnosis, education, and treatment of Kawasaki Disease; and

WHEREAS, The lack of public knowledge and understanding of Kawasaki Disease plays a significant role in the overwhelming number of undiagnosed and untreated cases of KD; the dissemination of inaccurate, misleading information also contributes to the obstacles preventing diagnosis and treatment of the disease; and

WHEREAS, Missed diagnosis of Kawasaki Disease can lead to permanent heart disease and untimely death, which places an unnecessary financial burden on the health care system; and

WHEREAS, A lack of knowledge, combined with the issue that symptoms can disappear, has a particularly detrimental effect on the diagnosis and treatment of Kawasaki Disease; and

WHEREAS, There is a need to educate health care professionals, parents, and the general public, who could be at unknown risk, about Kawasaki Disease and a need for well-trained physicians and emergency room professionals capable of conducting timely diagnosis and treatment activities; and

WHEREAS, Studies by the Kawasaki Disease Research Center and others consistently reveal that through proper and comprehensive diagnosis and treatment the symptoms and effects of KD can be substantially decreased and quality of life for the individual can be improved; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare January 26, 2011 as "Kawasaki Disease Awareness Day" and recognize Kawasaki Disease as a significant health concern; and be it further

RESOLVED, That we encourage all citizens of Illinois to find out more about Kawasaki Disease and its signs and symptoms and to seek the appropriate treatment and care, if necessary; and be it further

RESOLVED, That we encourage medical professionals and researchers to consider ways to improve access to appropriate research information as to cause and patient treatment with the purpose of improving the quality of life for children and adults with Kawasaki Disease.

HOUSE RESOLUTION 616

Offered by Representative Guzzardi:

WHEREAS, On March 17, 2020, the Illinois Supreme Court issued an emergency response to the COVID-19 pandemic by allowing Illinois courts to establish and update, as necessary, temporary procedures, including the use of remote technology, to minimize the impact of COVID-19 on the court system while continuing to provide access to justice; and

WHEREAS, In May of 2020, the Illinois Supreme Court adopted the "Illinois Supreme Court Policy on Remote Court Appearances in Civil Proceedings" to allow and encourage the broad use of remote court appearances; and

WHEREAS, The subsequent development of a vaccine and fluctuating changes in COVID-19 numbers allowed the resumption of in-person court hearings periodically throughout the pandemic but on a sporadic and county by county basis; and

WHEREAS, The National Juvenile Defender Center (NJDC) issued a report in March of 2021 entitled "Due Process in the Time of COVID" that examined the use of remote technology on the ability of lawyers to represent children in conflict with the law; and

WHEREAS, The NJDC report, based on interviews with lawyers representing children in 38 states, concluded that "the shift to technology-based communications and remote hearings threatens young people's constitutional rights, including fundamental aspects of effective legal representation, due process, and access to courts"; and

WHEREAS, The NJDC report also found that "the pandemic has magnified the disparate treatment of youth of color in the delinquency system and the disproportionate danger youth of color face due to their overrepresentation in facilities and the system as a whole"; and

WHEREAS, The NJDC report cautioned that the "findings raise serious concerns about the future operations of juvenile courts once the pandemic subsides...Technology-based communications have caused significant barriers in client communication and access to counsel"; and

WHEREAS, The NJDC report finds that "every person accused of a crime has a constitutional right to be present at hearings in which their participation may affect the outcome"; and

WHEREAS, Privacy concerns and technological challenges with the use of remote conferencing technology has a chilling impact on confidential communication between the attorney and the client during hearings; and

WHEREAS, In interviews conducted by the Juvenile Justice Initiative with six children who were sentenced to juvenile prison in the Illinois Department of Juvenile Justice resulting from Zoom court hearings, the children were concerned when speaking with their lawyers through remote technology that

their statements would be overheard by another person, such as counselors or correctional officers, who may be just outside the room where they were teleconferencing; and

WHEREAS, Remote conferencing limits the capacity of an attorney to ascertain the true level of comprehension of the legal process by their juvenile client; and

WHEREAS, Virtual hearings limit the capacity of children to convey emotion and read subtle cues and gestures; and

WHEREAS, Virtual hearings dehumanize children; and

WHEREAS, A report from the Brennan Center for Justice (Brennan Center) entitled "The Impact of Video Proceedings on Fairness and Access to Justice in Court" highlights some of the negative impacts of remote hearings; and

WHEREAS, The Brennan Center report includes a study of Cook County's early use of remote technology in felony bond hearings, beginning in 1999, where defendants participated in bond hearings through closed-circuit television; and

WHEREAS, The study of over 645,000 Cook County felony bond hearings between 1991 and 2007 concluded that the average bond amount was 51 percent higher when the hearing was virtual and that some cases saw increases of as much as 91 percent in bond amount; and

WHEREAS, The study, along with a class action lawsuit, caused Cook County to voluntarily return to live bail hearings; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois Supreme Court to exercise its authority to require courts throughout Illinois to responsibly transition hearings conducted under Article V of the Juvenile Court Act of 1987 back to in-person hearings with priority to those hearings where liberty interests are at stake; and be it further

RESOLVED, That we urge the Illinois Supreme Court and the Administrative Office of the Illinois Courts (AOIC) to exercise a rights-based approach when weighing the impact of, and determining policy on, remote court appearances, especially those under Article V of the Juvenile Court Act, focusing primarily on protecting children's rights to in-person participation and confrontation, including the benefits of children being able to meet with their lawyers in person prior to and after court hearings; and be it further

RESOLVED, That we urge the Illinois Supreme Court and AOIC to work to ensure that court policies, processes, and procedures implemented to protect the health and well-being of youth involved in the justice system do not infringe upon their access to counsel and their right to a fair trial; and be it further

RESOLVED, That we understand that with the possibility of COVID-19 variants or another significant public health crisis there may be times when the Illinois Supreme Court deems it appropriate to transition to virtual hearings for the purpose of protecting the health and well-being for all court hearing participants but that the use of remote technology shall be a last resort for as short a time as possible and all efforts should be made to ensure children have their lawyers physically present during virtual hearings, especially in cases where liberty interests are at stake.

HOUSE RESOLUTION 627

Offered by Representative Sosnowski:

WHEREAS, Professional sports franchises often relocate to address seating capacity limits, restructure debt, modernize the stadium experience, or to gain full authority over a new stadium; and

WHEREAS, The Chicago Bears professional football team has expressed a willingness to buy property in the Village of Arlington Heights; and

WHEREAS, Chicago Bears fans have also expressed an openness toward the team moving, with a recent informal survey of 6,000 people by Patch.com indicating that over 70 percent of respondents would like to see the team move; and

WHEREAS, The former Arlington Park property presents itself as a fresh development opportunity for the Village of Arlington Heights and the Chicago Bears team; it is conveniently situated off a major highway, just a twenty-minute drive from O'Hare International Airport, and, crucially, it has its own dedicated stop on the Metra commuter rail line; and

WHEREAS, The Chicago Bears' current lease payment to the Chicago Park District is \$6.48 million per year, though the team only paid \$3.1 million in 2020 after fans were not allowed to attend games because of the COVID-19 pandemic; and

WHEREAS, Taxpayers have covered over \$430 million of the Soldier Field renovation project; this is a figure that will balloon substantially before the debt fully matures and is paid off in 2032; and

WHEREAS, The economics of major professional sport leagues have been changing dramatically in recent years; from television and streaming rights to team-sanctioned legalized sports betting, worldwide merchandising deals, and massive media empires, teams have become corporate conglomerates with wide-ranging interests far beyond the stadium; and

WHEREAS, The location of the Chicago Bears team matters much less than their name, which implies that the team is one with Chicago so long as the team keeps its namesake; and

WHEREAS, Moving to a stadium in Arlington Heights presents an economic opportunity for a top-of-the-line stadium featuring a higher capacity and burgeoning entertainment, restaurant, and retail industry; the Arlington Heights location provides easier access via the State's roadways and Metra commuter rail lines; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the owners of the Chicago Bears organization to reach an agreement that all parties see as equitable and beneficial to move the team to the former Arlington Park property; and be it further

RESOLVED, That the Chicago Bears organization should move to the Arlington Heights location without requesting incentives from local or state government; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Chicago Bears organization, Chicago Mayor Lori Lightfoot, and Arlington Heights Mayor Tom Hayes.
