HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 391

Offered by Representative Howard:

WHEREAS, The adult female population in prisons in the State of Illinois was 2,806 in 2004, a 154 percent increase over the past ten years; and

WHEREAS, Of this population, less than 30 percent of these female prisoners were incarcerated for committing violent crimes; and

WHEREAS, Cook County Jail currently houses over 1,300 women on any given day and, of this population, approximately 90 percent are charged with non-violent crimes; and

WHEREAS, In prisons in the State of Illinois, 82 percent of women are mothers and almost 50 percent have children under five years of age; and

WHEREAS, Each year at least 25,000 children in the State of Illinois are impacted by maternal incarceration; and

WHEREAS, In the State of Illinois, at least 60,000 minor children will have their mothers spend time in a State prison while they are children; and

WHEREAS, An estimated 80 percent of all incarcerated women in the State of Illinois suffer from substance abuse problems; the State of Illinois can place fewer than 20 percent of all incarcerated women into its substance abuse programs; and

WHEREAS, It is a known fact that drug addiction causes crime, destroys the family structure, creates havoc in neighborhoods, and leaves paths of destruction in its wake; individuals convicted of crimes who have not received meaningful treatment while incarcerated continue to commit crimes; and

WHEREAS, In the United States, by mid-year of 2003, the number of adult female inmates rose 6.3 percent over the previous year; and

WHEREAS, Community-based alternatives to incarceration for women convicted of non-violent offenses would allow children to stay with their mothers while their mothers receive appropriate treatment; with the appropriate treatment, the mothers would be less likely to commit additional offenses and would be able to re-enter society as tax-paying citizens; in addition, their children would be less likely to become the next generation of incarcerated individuals; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize May 11, 2007, as Mothers in Prison, Children in Crisis Day in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Chicago Legal Advocacy for Incarcerated Mothers (CLAIM).

HOUSE RESOLUTION 395

Offered by Representative Joyce:

WHEREAS, The Urban Park and Recreation Recovery Program (UPARR) is a matching federal grant program administered by the National Park Service of the Department of the Interior; and

WHEREAS, The purpose of the program is to provide funding for the rehabilitation of parks and recreation areas in cities and urban communities; and

WHEREAS, Since the establishment of the program in 1978, approximately 1500 individual grants totaling more than \$270,000,000 have been made to eligible cities and counties; and

WHEREAS, No funds have been appropriated under UPARR for the past 5 years; and

WHEREAS, Urban park development is essential for economic revitalization, environmental stewardship, and public recreation; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Congress of the United States of America to support funding for the Urban Park and Recreation Recovery Program; and be it further

- (1) allow states the flexibility to use growth model assessment models to enhance existing measures of student progress;
- (2) provide flexibility in program implementation with respect to varying student and teacher needs related to diversity of geography, wealth, and background;
- (3) revise assessment guidelines for special needs students so that such students are more fairly assessed considering their specific individualized education programs and, therefore, better served;
- (4) resolve other contradictions between NCLB and the Individuals with Disabilities Education Act (IDEA);
- (5) address issues arising from students who are counted in multiple groups when determining adequate yearly progress;
- (6) allow schools to offer, and provide full funding for, important supplemental education services before schools are forced to offer choice;
- (7) provide greater flexibility when determining the sizes of groups regarding assessment subgroups;
- (8) school improvement grants must be funded so that the sanctions placed on schools will result in improved student achievement and the reversal of negative trends;
- (9) seek greater consistency in state certification criteria and the federal "highly qualified" designation;
- (10) the highly qualified teacher provisions of NCLB require clarification, greater flexibility regarding alignment with state certification, and appropriate, specific, technical assistance in order to ensure compliance; and
- (11) resident school districts of special needs students attending private schools must pay for IDEA services delivered at a private school; and be it further

RESOLVED, That suitable copies of this resolution be delivered to President of the United States George W. Bush, United States Secretary of Education Margaret Spellings, and each member of the Illinois congressional delegation.

WHEREAS, Suicide among veterans suffering from post-traumatic stress disorder (PTSD) is a serious problem; and

WHEREAS, Veterans suffering from PTSD have special needs and should have available a comprehensive program for reducing the incidence of suicide among their number; and

WHEREAS, The elements of such a comprehensive program should include the following: destigmatizing mental illness; training of employees of the U.S. Department of Veterans Affairs and other personnel who interact with veterans; family education and outreach; peer support; health assessments; counseling and treatment; designation of suicide prevention counselors; research on best practices; substance abuse treatment; 24-hour mental health care; and a telephone hotline for obtaining information and referrals; and

WHEREAS, H.R. 327 and S. 479, currently before Congress, provide for such a comprehensive program

for reducing the incidence of suicide among veterans and require the U.S. Secretary of Veterans Affairs to submit to Congress a report on the programs and activities of the Department of Veterans Affairs to reduce the incidence of suicide among veterans; and

WHEREAS, Congress should pass H.R. 327 and S. 479 so that veterans who have sacrificed much for our country can obtain the health care that they need; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to pass H.R. 327 and S. 479 in relation to veterans suicide prevention; and be it further

HOUSE RESOLUTION 398

Offered by Representative Feigenholtz:

WHEREAS, Over 7,000 women in the State of Illinois are expected to be diagnosed with breast cancer in 2007; and

WHEREAS, Over 1,700 women in the State of Illinois are expected to die from breast cancer in 2007; and

WHEREAS, In the United States, a woman receives a diagnosis of breast cancer every three minutes, making that disease the most frequently diagnosed of all cancers affecting women; it was expected that, in 2007, approximately 178,000 cases of breast cancer would be diagnosed among women in the United States and that over 40,000 women would succumb to the disease; and

WHEREAS, Without a cure, one in eight women in the United States will continue to be diagnosed with breast cancer; moreover, the next quarter-century will see an estimated 5 million American women and 25 million women worldwide diagnosed with breast cancer, and more than a million American women and some 10 million women worldwide could die; and

WHEREAS, The State of Illinois is home to extremely innovative and effective organizations that fight breast cancer, including Illinois Affiliates of Susan G. Komen for the Cure, the Illinois Breast and Cervical Cancer Early Detection Program, the STAND Against Cancer Initiative, the Hispanic Breast and Cervical Cancer Initiative, ACCESS Community Health Network, Y-ME Illinois, and the American Cancer Society Illinois Division; and

WHEREAS, Illinois has a special place in the history of breast cancer advocacy, with Peoria being the home of Susan G. Komen and her sister, Nancy Brinker, who founded the world's largest breast cancer organization, Susan G. Komen for the Cure, based on her promise to her dying sister to do everything possible to fight the disease; and

WHEREAS, Early detection of breast cancer is the key to surviving the disease, with survival rates of over 95% when the cancer is caught early while still confined to the breast; and

WHEREAS, Public and private partnerships involving Illinois Affiliates of Susan G. Komen for the Cure, the Illinois Breast and Cervical Cancer Early Detection Program, the STAND Against Cancer Initiative, the Hispanic Breast and Cervical Cancer Initiative, ACCESS Community Health Network, Y-ME Illinois, and the American Cancer Society Illinois Division are supporting early detection of breast cancer, especially for low-income and uninsured women; and

WHEREAS, Illinois has made a strong commitment to provide breast cancer screening services to low-income and uninsured woman in the State of Illinois within ten years; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Illinois House of Representatives is committed to the goal of providing breast cancer screening services to every low-income and uninsured woman in the State of Illinois and commends those thousands of Illinois breast cancer advocates and survivors who are fighting to achieve this goal.

WHEREAS, ALS is a fatal neurodegenerative disease characterized by degeneration of cell bodies of the lower motor neurons in the gray matter of the anterior horns of the spinal cord; and

WHEREAS, The initial symptom of ALS is weakness of the skeletal muscles, especially those of the extremities; and

WHEREAS, As ALS progresses the patient experiences difficulty in swallowing, talking, and breathing; and

WHEREAS, ALS eventually causes muscles to atrophy and the patient becomes a functional quadriplegic; and

WHEREAS, ALS does not affect a patient's mental capacity, so that the patient remains alert and aware of his or her loss of motor functions and the inevitable outcome of continued deterioration and death; and

WHEREAS, On average, patients diagnosed with ALS only survive two to five years from the time of diagnosis; and

WHEREAS, research indicates that military veterans are at a 50% or greater risk of developing ALS than those who have not served in the military; and

WHEREAS, ALS has no known cause, means of prevention, or cure; and

WHEREAS, Amyotrophic Lateral Sclerosis Awareness Month increases the public's awareness of ALS patients' circumstances and acknowledges the terrible impact this disease has not only on the patient but on his or her family and the community and recognizes the research being done to eradicate this horrible disease; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we proclaim the month of May 2007 as Amyotrophic Lateral Sclerosis Awareness Month in the State of Illinois; and be it further

RESOLVED, That we memorialize the President and Congress of the United States to enact legislation to provide additional funding for research in order to find a treatment and eventually a cure for amyotrophic lateral sclerosis; and be it further

RESOLVED, That suitable copies of this resolution be presented to the President of the United States and each member of the Illinois congressional delegation.

HOUSE RESOLUTION

HOUSE RESOLUTION 402

Offered by Representative Madigan:

WHEREAS, On March 7, 2007 before a joint session of the Illinois House and Senate, Governor Rod R. Blagojevich delivered a combined State-of-the-State and Budget Address; and

WHEREAS, Based on his concern that, "Many large corporations pay little or nothing in corporate income taxes and are not paying their fair share to meet the state's ongoing infrastructure, education,

healthcare, and public safety needs," Governor Blagojevich, during his speech, asked that the General Assembly address this situation by the implementation of a Gross Receipts Tax (GRT) to begin January 1, 2008; and

WHEREAS, Governor Blagojevich's proposed GRT is a privilege tax imposed on virtually all business entities engaged in a trade or business conducted, in whole or in part, within Illinois; and

WHEREAS, Governor Blagojevich's proposed GRT would be assessed at a rate of 1% for manufacturing, retail, and wholesale companies, and all other businesses, such as those that provide services, would pay a rate of 2%; and

WHEREAS, Governor Blagojevich projects that his proposed GRT would raise \$7.6 billion in annual revenue for the State; and

WHEREAS, Governor Blagojevich's proposed GRT would exempt businesses with gross revenues of \$2,000,000 or less, non-profit organizations, and governmental entities; it would also exempt certain transactions, services, and goods and allow certain credits; and

WHEREAS, While no House member has of this date introduced a bill to enact Governor Blagojevich's proposed GRT, currently pending in the Illinois Senate is Senate Bill 1, Amendments #1 and #2, the legislative form of Governor Blagojevich's proposed GRT; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that those voting "aye" on this resolution are in support of Governor Blagojevich's proposed Gross Receipts Tax and urge that legislation to enact it into law be passed by the General Assembly as soon as possible, and those voting "no" on this resolution do not support Governor Blagojevich's proposed Gross Receipts Tax and believe that it should not become law; and be it further

RESOLVED, That a copy of this resolution be presented to all State Constitutional Officers, the Minority Leader of the House of Representatives, the President of the Senate, and the Minority Leader of the Senate.
