Members of the General Assembly, I am delighted to welcome to the House chamber today the Consul General of Japan in Chicago, the honorable Hiroshi Tajima. Consul General Tajima was previously the Deputy Assistant Minister of Economic Affairs Bureau and the Foreign Policy Bureau of the Ministry of Foreign Affairs for Japan. He was also the Ambassador in charge of Economic Diplomacy and the Senior Official of Japan for APEC. The Consul General has also served in the Japan-U.S. Security Treaty Division, Japan-U.S. Status of Forces Agreement Division, and the National Security Policy Division. Members of the General Assembly, let's give a warm House welcome to the Consul General, Tajima Hiroshi."

Consul General Tajima: "Speaker Welch, Minority Leader McCombie, esteemed Members of the Illinois House of Representatives, I feel greatly honored to have the opportunity to address you today. Before I begin, I'd like to express my sincere

condolences and sympathy to the many injured and loss of lives on the Interstate 55 due to the dust storm, which occurred this Monday. I served as Consul General of Japan in Chicago for a year and eight months. In that time, I have had the good fortune of meeting many incredible people and promoting the robust Japan-Illinois partnership. Japan and Illinois have a long history of meaningful exchanges, and I'm enjoying being an active part of the process. Japan has learned a great deal from Illinois and the United States in a variety of areas, including everything from business, to education, to favorite pastimes. Some of you might have watched the exciting World Baseball Classic championship game in March this year. Japan narrowly defeated the United States. Last year, Japan celebrated the 150th anniversary of baseball in the country. Baseball, introduced by the United States, has become one of the most popular sports in Japan. From 1910 to 1936, the University of Chicago baseball team traveled to Tokyo every five years to play against Waseda University. Today, Japan is proud to have many Japanese players in the MLB, including Shohei Ohtani of the Los Angeles Angels, Yu Darvish of San Diego Padres, and Seiya Suzuki of the Chicago Cubs. The bilateral relationship between Japan and the United States is slightly older than the baseball exchange. In 1872, the first Japanese nationals visited Chicago as part of the Iwakura Mission. The goal was to learn about systems of government and education. The mission included five girls, the youngest of whom was only six years old. The girl, Umeko Tsuda, ended up studying Washington, D.C. and becoming an educator. She went on to establish the first women's college in Japan.

Starting next year, her face will appear on the new Japanese 5 thousand yen bill. Today, the active and growing economic partnership between Japan and Illinois forms the firm foundation of our relationship. We have always looked to the future and worked to create a mutually beneficial relationship. Amid the Japan-U.S. trade war in the 1980s, Illinois became the first state to reach out to Japan. Illinois made a determined effort to bring in Japanese investment to the state. Illinois opened the trade office in Osaka in 1983 and then opened a second office in Tokyo in 1987. I am certain that Illinois' effort paved the way for the robust economic ties enjoyed by Japan and Illinois as well as the United States today. As globalization has progressed, we have come to realize that our local economy is increasingly influenced by the international security situation. Recently, we have faced many challenges, including supply chain disruptions caused by COVID, unprecedented price hikes as a result of the war in Ukraine, and information security issues. To maintain the smooth flow of trade and investment, we must seriously address the increasing uncertainty in the Indo-Pacific region. This is an urgent and pressing issue. Security concerns have become especially severe in Northeast Asia and the Indo-Pacific region. Japan recognizes the threats of North Korea's continued development of nuclear weapons and ballistic missiles. Japan also recognizes China's advancement of its military capacity without transparency. Additionally, trans-national threats have grown more serious because of technological progress. In December last year, the government of Japan formulated a new

National Security Strategy and will fundamentally reinforce its own defense capabilities and its comprehensive defense architecture. I cannot emphasize enough the Japan-U.S. alliance's strategic value. Japan and the United States should continue to strengthen our relationship, building on what we have established and building our global allies together under shared values and principles, such as freedom, democracy, human rights, and the rule of law. Japan hosts the G7 Summit in Hiroshima later this month. With the world more connected than ever, Japan and the United States need to stand together and take the lead. A strong Japan-U.S. relationship also ensures robust economic ties between Japan and Illinois. Currently, there are 663 Japanese business facilities in Illinois. They employ over 43 thousand people. Manufacturing accounts for 61 percent of business facilities and 84 percent of total employment. The remaining 40 percent of the business facilities represents a wide range of businesses. Financial, retail, and IT companies have offices in Chicago. Logistical, food, robotics, and pharmaceutical companies are located around O'Hare. Manufacturing companies are operating in Central and Southern Illinois. J-Power USA, an electric company, has power plants in Elwood. It provides 10 percent of electricity to all Illinois households by using cutting-edge green technology. Japanese companies are working hard for Illinoisans. Their success is your happiness. In addition to direct investment by Japanese companies, Japan also imports 2.3 billion dollars' worth of goods and services from Illinois. Japan is Illinois' seventh largest exporter and the fifth largest import partner. Illinois products are essential

to improving the quality of life for Japanese people. Abbott, an Illinois company, has been operating in Japan since 1962. Abbott provides heart pacemakers and innovative glucose level monitors that are indispensable to many Japanese people with particular health problems. CGB Enterprise, owned by two Japanese local companies, has many grain handling facilities throughout Illinois and exports soybeans and corn to Japan. Earlier, I mentioned that Illinois opened its first trade office in Osaka. Did you know that Osaka has a long and storied history with Chicago? Chicago and Osaka have been sister cities since 1973. This year marks the 50th anniversary of the sister-city relationship. The two cities are vibrant commercial hubs with a friendship sustained by the grassroots efforts of dedicated citizens. Springfield shares a sister-city relationship with Ashikaga City, about 60 miles north of Tokyo, the home of one of the country's oldest schools. Each year, Japanese students in Ashikaga City participate in a competition where they recite Abraham Lincoln's Gettysburg Address and write an essay about how the speech applies to modern issues. People-to-people exchanges are key to the long partnership between Japan and Illinois, and these exchanges take various forms. Since 1987, the government of Japan has been recruiting young Americans to teach English in Japan as assistant teachers at Japanese public schools or to promote international relations working as coordinators in local government. Through the Japan Exchange and Teaching Program, or the JET in short, 278 Japanese... young Americans, just from the Midwest, are currently working all over Japan, representing the United States as cultural ambassadors. About

38 thousand Americans are JET alumni. The amazing Illinoisans who are interested in and love Japan are our greatest asset. We deeply appreciate their efforts and continue to support their activities. Goodwill between people from all backgrounds create a foundation of trust and mutual understanding.. mutual understanding. Trust and understanding create an environment where businesses and governments can grow and thrive, an environment that accelerates the flow of trade and fosters investment. The relationship between Japan and the United States as well as Japan and Illinois truly exemplify this connection between goodwill and productive economic partnership. In my role, I have the privilege of shining a light on the friendship between the wonderful people of Illinois and Japan. My office looks forward to continuing to work with you all and with the great people of Illinois. Thank you for listening and for championing the Japan-Illinois partnership."

In 2021, 5,190 workers nationally were killed on the job. We know that 1,130 of those were Latino, killed at a rate 25 percent higher than the national average. And 653 workers were black, killed at a rate 11 percent higher than the national average. This must change, and we must work as a society and in this General Assembly to be better. As a railroader, I strive to return home healthy, unharmed, and in the same condition as I reported for duty. While the passage of the Workers' Rights Amendment last fall makes Illinois the most proworker state in our nation and codifies our collective commitment to employee and workplace safety, we still have more work to do. It's up to all of us to continue our progress and to ensure each and every worker returns home safely every day too. Thank you very much."

Mireya brightened every room with her love for her community and passion for language access and stayed connected to her roots throughout her life. She became an excellent cook of traditional Mexican cuisine and was passionate about Latin music, which was expressed through dancing. Mireya passed away on December 14 of '22. She was the wife of Raymond

Postponed Consideration, we have House Bill 3957, Representative Syed. Representative Syed is recognized."

I rise today to present House Bill 3957, which protects Illinois consumers from skyrocketing prescription cost by banning the price gouging of generic drugs when there are three or fewer manufacturers in the market. This Bill does two things. This Bill defines price gouging as a specific price... percentage increases within a given period of time, and it gives the Attorney General's Office the power to investigate price gouging in those cases and seek remedies for consumers. Lifesaving medication is only lifesaving if people could afford it. I urge an 'aye' vote of this Bill. Thank you."

Syed: "So, if the price increases are justified through research and development or marketing, then it is not considered price gouging under this legislation."

Caulkins: "And who makes that determination, please?"

Syed: "The generic drug manufacturer would have to make a case for that, and the Attorney General's Office has the power to assess that before they decide to investigate."

Caulkins: "And is the Attorney General's Office held to this standard in your Bill? That if a drug company were able to..."

or presents some factual information that this is why they've increased the drug price, is the Attorney General then held to that standard that he cannot pursue them?"

Syed: "With the way this legislation's written, if the price can be justified because of R&D, because of marketing, then it is not considered price gouging. In those cases, the Attorney General's Office does not have the power to investigate."

Caulkins: "And then part of your explanation is it... or it presents some kind of a burden, a burden on the consumer. How do you define a burden on the consumer?"

Syed: "So, you know, this adding language of it needing to be an unduly or excessive burden in price gouging... of price gouging actually just makes the threshold higher. So, not only do you have to have the price gouging be defined within those specific percentages, but it also needs to show that it presents an unduly and excessive burden as, you know, this terminology that is commonly used in... by lawyers. But it simply removes some references to parking that was supposed to have been removed completely with the first Amendment."

Windhorst: "Though this Bill will put a mandate on business that does not currently exist. Is that correct?"

Mah: "Yes, it does. But I think that many businesses will find that there are easily accessible mechanisms for them to offer these transit... pre-tax transit programs because there is already an infrastructure set up to offer them. And so, it would not be an undue burden."

lessons at the age of four. However, she swiftly proved herself a prodigy when she tried violin three years later. When she was just 10, Chung debuted with the Seoul Philharmonic Orchestra, playing Felix Mendelssohn's *Violin Concerto*. And at 12, she traveled to Japan for her first major international tour. Chung's steady rise to fame in South Korea soon led her mother to move her family to the United States to reach a larger audience and further her musical career along, along with Chung's two siblings, who were also on their way to becoming successful professional musicians. At 13, Chung attended the Juilliard School of Music in New York. During her time there, she studied under the eminent teacher Ivan Galamian, who gave her the nickname Cookie. Chung was a coworker of the Edgar Leventritt Competition, which led to prestigious engagements across North America, including a concert with the Chicago Symphony Orchestra. And at the time, reviewers praised the rare personality that shown through Chung's playing, calling her performances sensitive and finely shaded with flashes of grit and fire. Throughout the rest of her performing career, she shared her gifts with orchestras in Berlin, London, and New York. In 2005, she suffered an injury to her hand which prevented her from high-level playing for years. However, she used her time rehabilitating to return to Juilliard and teach music to the next generation of performers. Chung's music career has spanned six decades and resulted in a lengthy discography of countless recordings, both solo and in concert with her siblings. And she has been built a legacy of high-level recognition, starting at a time when female performers often
