Jasmine is with Chicago Indian American (sic-American Indian) Community Collaborative in Chicago, Illinois. Jasmine is the guest of Representative Faver Dias. Members and guests are asked to refrain from starting their laptops, turn off cell phones, and rise for the invocation and the Pledge of Allegiance."

Jasmine Gurneau: "[Recited in Oneida/Menominee language.] Hello, everyone. My name is Jasmine Gurneau. I am a citizen of the Oneida Nation and a descendent of the Menominee Nation, and I'm proud to serve as the board president for the Chicago American Indian Community Collaborative. I'd like to begin this Session today by recognizing the land of the Three Fires people, the Ojibwe, Odawa, and Bodewedmi, but also the Ho-Chunk, Peoria, Kaskaskia, Piankashaw, Wea, Miami, Mascoutin, Sauk and Fox, Mesquaki, Kickapoo, and Chickasaw Nations. As you can tell by the many tribal nations I named, Illinois and these lands and territories have always been an important place of gathering, a place of knowledge sharing, and a place in which we deliberately always traded with each other and have engaged in political exchange in order to build new worlds together. I wanted to acknowledge that context as we open this Session here today. I also want to share that land acknowledgments without action and commitments to Native people today and in the future are empty gestures. As people who are in public service, we appreciate the leadership and service that you all provide. There is nothing more honorable than those who are in service to community. We are so happy

to be here today and to build relationships with you, to have the opportunity to build relationships, to heal historic harms and build into the future in positive ways. As someone who was born and raised in the State of Illinois and raising my family here, I'm so proud to stand here and say that my kids, who are here in the Speaker Gallery just above me... sorry, gallery today, that they're witnessing the state, you all, upholding your responsibility to Indigenous sovereignty and, specifically, the Prairie Band Potawatomi. My kids will grow up with a story of justice being done, of lands being returned to our Native people. In the spirit of our moral responsibilities, I hope you all continue holding the Three Fires people and Native nations in your rights, responsibilities, and relationships here, now, and in the future so that we can build the worlds that we want. Waewaenen, Yaw^ko, Dan^to."

It is my hope that this Body will engage with these American Indian leaders here today and take a step towards a

Lilly: "Thank you. Good afternoon. Today, I'd like to rise to talk about the Black History Month honor and recognition of... of individuals who have contributed to our great country. Today, I wish to honor Percy and Anna Julian, a husband and wife who are an important part of the history here in Illinois, here in my hometown of Oak Park, where they have made a significant difference in all of the sciences across the world. A little bit about Mr. Julian. Percy Julian, born in 18... thank you, Mr. Speaker. Percy Julian, born in 1899, was one of the most important chemists in our nation history. He worked at the Glidden Company in Chicago and later his own lab in Julian Laboratories in Franklin Park. He worked to synthesize new drugs, where he led a serious medical breakthroughs. Drugs that address many of the medications that allow us to receive treatment for glaucoma... glaucoma and also many of the hormonal issues that are... many of us are dealing with here in our great state. These drugs allowed us to have wide availability to make sure that we are well and our issues are addressed. He also was the first black chemist inducted into the National Academy of Sciences and the second black scientist inducted in the National Academy of Sciences. But he was not alone. His loved one, his wife, had a lot to do with his success and also her own success. Anna Johnson Julian, born in 1901, was the first black woman to earn her PhD in psychologies, where she received her degree in 1937 from the University of Pennsylvania. She served as the national president of the historical black sorority Delta

Sigma Theta, which I am a member of, red and white. After working for a decade in D.C. as a researcher, she gained... she joined her husband in Chicago where she was civic activist and founder of the Julian Laboratories along with her husband, Percy. They both served the... served in the country... served in the company throughout its entirety. She served as the vice president. In 1950, the Julians moved to Oak Park, where I also lived and attended school. And I'm very proud to say that they have a wonderful home that we are restoring in Oak Park as a... as a museum for you to see all of their good work. At this time, as you know, there were few, very few, black people living in Oak Park, but they were making a difference and being great neighbors to many. They were very supportive of many of the progress that was happening in our great city here in Chicago. Even before they moved to Oak Park, the property was bombed. We... we wanted to make sure... the family wanted to make sure that in restoring the property that they will... will be able to sustain the riches and the information that they have provided to our great country and our great city around the sciences. Despite these racial attacks on their homes and their property, the family sustained themselves in Oak Park, and their daughter remains in that location today. It is important to know that because of the tenacity and what they have brought to the community, Oak Park has named their middle school after Percy Julian and is titled Julian Middle School. And this family, who has pioneered not only in Illinois but throughout our country, has made history, has made black history. And with the memory of Percy and Anna and their contributions to science and the
