The Office of Constituent Services is a bridge between the Department and the community at large. This report was compiled in accordance with requirements outlined in 730 ILCS 5/3-7-2(i)(2) (Public Act 102-108) which went into effect June 10, 2022.

The reporting period for this General Assembly report is December 1, 2023, through June 30, 2024.¹ During this reporting period, the Constituent Services Unit received approximately 10,722 concerns. These concerns were received via webmaster, email, phone, and letters. This report indicates the nature of the concerns received, and in addition to the requirements outlined in Public Act 102-108, includes subcategories to better track those concerns received. This report also details how those concerns were received, number of concerns received, and concerns received by facility.

The Constituent Services Unit is comprised of a Community Outreach Administrator, a Community Outreach Specialist (Family Liaison), and Administrative Assistant II. The Family Liaison serves as the focal point of contact between the public and staff within the agency to assist in addressing concerns raised. The Liaison contacts facilities and units within the Department notifying them of concerns received and requesting the concerns be reviewed and addressed. The Community Outreach Specialist works alongside the Liaison in developing communication processes between the Department, constituents, family, and friends. These positions together, with the assistance of the Administrative Assistant II, work diligently to forward every concern received by the Unit to the appropriate facilities and units in a timely manner.

Upon receipt of a concern, the Unit provides a response back to the constituent often using the same method of communication that was initiated by the constituent, while also following up with the constituent for more information as necessary. Additionally, in responding to concerns, the Unit provides information tailored specifically to the issue raised. This information is derived from the knowledge this Unit has in the day-to-day operations of the Department as well as knowledge of its policy and procedures. Where the Unit is unable to disclose information due to HIPAA and/or other confidentiality laws, generalized information relevant to the constituent's concern is provided, and the concern is forwarded to the appropriate facility and/or units for review and handling.

Approximately twenty-eight (28) concerns received by the Chief Inspector of the Department were referred to the Department's Internal Affairs and Investigation unit for review. These concerns centered on the safety and security of individuals and staff, claims of excessive force, security threat groups, and staff conduct. Upon forwarding these concerns, the Unit received confirmation from Internal Affairs that these concerns were received and would be reviewed and handled pursuant to policy and procedure. Moreover, constituents were also informed that their concerns had been received and were forwarded to the appropriate unit for review and handling. Of the twenty-eight concerns that were forwarded, twenty-four (24) were found to be unsubstantiated, one (1) was substantiated, and three (3) are currently under review.

¹ The first six (6) months of this fiscal year were reported in the CY23 report that was filed on February 5, 2024. 730 ILCS 5/3-7-2(i)(2), requires that the Department prepare an annual report regarding the activities of the Constituent Services Unit point of contact, and submit it to the Governor and General Assembly by January 1 of each year. The statute is silent as to whether this report is to be based on a fiscal year end or a calendar year end. In order to comply with the statute, the Department is providing the Constituent Services Unit data to the Governor's Office and General Assembly on a fiscal year end beginning January 1, 2025. Beginning with the next report and going forward, the Department will report data on a fiscal-year basis.

The Office of Constituent Services is a bridge between the Department and the community at large. This report was compiled in accordance with requirements outlined in 730 ILCS 5/3-7-2(i)(2) (Public Act 102-108) which went into effect June 10, 2022.

To continue to bridge the gap between the constituents and the Department, the Unit has made the following recommendations: (1) Continued training and resources to staff to assist in communications with Individuals in Custody as well as members of the public; (2) review and changes to the Department's Visitation Administrative Directive to assist in streamlining visitation processes across facilities, addressing the high volume of concerns of the family and friends of individuals in custody; (3) continued communication with community partners and stakeholders regarding agency decisions impacting the population, and continued town hall meetings and listening sessions for significant topics of community interest resulting in increased transparency and community collaboration; and (4) continued maintenance and improvement of Department website resources for ease of use and clarity of information, including but not limited to timely and thorough lockdown updates.
