Pursuant to 50 ILCS 706/10-25, I am submitting the annual report for the DeKalb County Sheriff's Office Body-Worn Camera Program. In 2023, we had approximately 37 sworn deputies with peace officer status issued body worn cameras.

In May of 2023, our department switched from Kustom Signals Vantage body worn cameras to Axon Body 3 cameras. During the year, there were no technical issues with the body cameras to report.

Supervisors are authorized to review relevant recordings any time they are completing a report, investigating alleged misconduct or reports of meritorious conduct, or whenever such recordings would be beneficial in reviewing the member's performance.

For instances in which body-worn camera footage was used in criminal prosecution within DeKalb County Sheriff's Office jurisdiction, please refer to the attached chart.
