Pursuant to 50 ILCS 706/10-25, I am submitting the annual report for the DeKalb County Sheriff's Office Body-Worn Camera Program. In 2024, we had approximately 37 sworn deputies with peace officer status issued body worn cameras.

During the year, there was one incident where a camera failed to record as expected. The device's firmware was updated, and it has operated properly since. No other technical issues were reported for the year.

Supervisors are authorized to review relevant recordings any time they are completing a report, investigating alleged misconduct or reports of meritorious conduct, or whenever such recordings would be beneficial in reviewing the member's performance.

For instances in which body-worn camera footage was used in criminal prosecution within DeKalb County Sheriff's Office jurisdiction, please refer to the attached chart.
