**Department Overview – Lockport Township Park District Police Department**

The Lockport Township Park District Police Department consists of fourteen (14) sworn officers, including a Chief of Police, a full-time sworn officer, and twelve (12) part-time sworn officers. These officers utilize eight (8) Axon Body 4 body-worn cameras.

**Technical Issues:**

Lockport Township Park District Police Department reports zero (0) technical issues with the Axon Body 4 body-worn camera.

**Review Process:**

The Chief of Police of the Lockport Township Park District Police Department reviews random body camera recordings monthly. These reviews consist of at least two (2) random video reviews for each officer. The Chief of Police will also review body-worn camera video when required for evaluation, investigation of complaints, and report completion.
