In accordance with 430 ILCS 65/11, a report listing all final decisions by a court of this State upholding, reversing, or reversing in part, any administrative decisions made by the Firearm Owner's Identification Card Review Board ("FCRB") concerning the Firearm Owners Identification ("FOID") Card Act must be submitted to you and the General Assembly. The FCRB received 12 relevant decisions from the Illinois courts during calendar year 2024, with respect to FOID card litigation. Enclosed is a summary of those cases, including information regarding one case that remains pending on appeal.

Firearm Owners Identification Card Act – Report of Court Decisions
430 ILCS 65/11(c)

Petitions for Relief Brought Under 430 ILCS 65/10

In five (5) relevant cases during calendar year 2025, the petitioner sought relief from the relevant firearm prohibition and/or an order directing ISP to issue a FOID card under the provisions of 430 ILCS 65/10. The court granted relief and directed ISP to issue a FOID card to the petitioner in four (4) instances. In all of those cases, FCRB did not appeal the orders.

1. *Borders, Amber v. Illinois FCRB* -- On April 5, 2023, Illinois State Police revoked Ms. Borders' FOID card following a determination that she presented a clear and present danger. Ms. Borders' FOID card was denied. Ms. Borders subsequently filed a petition for relief with the Firearm Owner's Identification Card Review Board ("FCRB"), which issued a final administrative order denying relief on November 22, 2023. Ms. Borders then sought judicial review in the Circuit Court of Cook County. On February 20, 2025, the court granted relief and directed ISP to issue a FOID card.
2. *Rojas, Yesenia v. Illinois FCRB* -- On July 26, 2023 Illinois State Police revoked Ms. Rojas' FOID card following a determination that she presented a clear and present danger. Ms. Rojas subsequently filed a petition for relief with the Firearm Owner's Identification Card Review Board ("FCRB"), which issued a final administrative order denying relief on February 28, 2024. Ms. Rojas then sought judicial review in the Circuit Court of Cook County. On August 1, 2025, the court granted relief and directed ISP to issue a FOID card.
3. *Sandmore, Kenneth v. Illinois FCRB* -- On January 19, 2023, Illinois State Police revoked Mr. Sandmore's FOID card following a determination that he presented a clear and present danger. Mr. Sandmore subsequently filed a petition for relief with the Firearm Owner's Identification Card Review Board ("FCRB"), which issued a final administrative order denying relief on May 22, 2024. Mr. Sandmore then sought judicial review in the Circuit Court of Cook County. On July 8, 2025, the court granted relief and directed ISP to issue a FOID card.
4. *Tito, Brian v. Illinois FCRB* -- On April 9, 2024 Illinois State Police revoked Mr. Tito's FOID card following his voluntary admission to a mental health facility. Mr. Tito subsequently filed a petition for relief with the Firearm Owner's Identification Card Review Board ("FCRB"), which issued a final administrative order denying relief on June 26, 2024. Mr. Tito then sought judicial review in the Circuit Court of Cook County. On May 4, 2025, the court granted relief and directed ISP to issue a FOID card.

The court denied relief in one (1) instance.

1. *Robinson, Shantasha v. Illinois FCRB* -- On February 23, 2024, Illinois State Police revoked Ms. Robinson's FOID card following her voluntary admission to a mental health facility. Ms. Robinson subsequently filed a petition for relief with the Firearm Owner's Identification Card Review Board ("FCRB"), which issued a final administrative order denying relief on June 26, 2024. Ms. Robinson then sought judicial review in the Circuit Court of Cook County. On June 4, 2025, the court denied relief.
