## 2025 Camera Grant Report

## **Body Worn Camera Reporting Information**

The Carol Stream Police Department has seventy (70) body-worn cameras. Currently, our sixty-two (62) sworn officers are issued a body-worn camera (BWC). The remaining eight (8) BWCs are kept for issuing to officers hired in the future or used as spares in the events an officer's camera becomes inoperable. The Carol Stream Police Department utilizes Axon Body 4 BWCs and Axon Fleet 3 in car cameras. There are twenty-nine (29) Fleet 3 cameras installed in Carol Stream Police Department Vehicles. At this time, we do not have any unusable cameras.

### **Technical Issues**

The Carol Stream Police Department has experienced few technical issues with our current body worn cameras. The most common error has occurred when a camera is docked and the display screen indicates a network connection error. When this does occur, the error is resolved by powering off the camera, restarting the camera and re-docking it.

### **Review Process**

Supervisors are authorized to review relevant recordings any time they investigate alleged misconduct or reports of meritorious conduct or whenever such recordings would be beneficial in reviewing a member's performance. Supervisors will randomly review recordings pertaining to their area of responsibility to ensure the equipment is operating properly and that officers are using the cameras appropriately and in accordance with training and department policy. The selection of recordings will be conducted in an impartial manner that promotes an equitable review of video footage from all officers under the supervisor's chain of command. Supervisors shall not review recordings for the sole purpose of searching for violations of department policy or law not related to a specific complaint or incident.
