And these were all community members and two of the preschoolers, a three, five, and another three year old. The three and five year old were siblings. So, I ask that you keep this community and families involved in your thoughts and prayers. It's just an unexplainable tragedy. National Safety Commission is on site. First responders involved, fire, sheriff, all the community members. They had a vigil last night, which hopefully will start the healing process but please extend and -- and share prayers and thoughts for the healing that needs to happen for this community.
